# Grant County Chaplaincy Fund

Recognizing the need for Chaplaincy care at The Legacy and Park View Assisted Living, a group of concerned folks began a grassroots effort to restore the Chaplaincy Program at our elder care facilities.

All indications pointed to funding as the biggest hurdle to overcome. Willing and qualified volunteers were available, but



for the program to succeed, a parttime Chaplain was needed, and the funding for that posi-

tion as well as a few supplies was illusive until they had the idea of establishing an operating fund in the GCCF to receive donations for the cause and pass them through to The Legacy to fund the position.

With a combination of an endowed fund to accumulate donations for the long-term future of the program and an operating fund to handle current ex-

penses, the Chaplaincy Program began its service in October of last year.



The Board of Directors of the Grant County Recreation established an endowed fund to plan for its future. The fund will grow over time from donations.

Grant County Recreation provides a wide variety of programs and services that promote a healthy lifestyle and enhance the quality of life in Grant County! Citizens of all ages and levels of physical fitness can find something at Grant County Recreation that they can enjoy.

Continuing to provide quality services at an affordable cost is a high priority for the REC Board. They are hopeful that as the fund grows, part of the cost of providing services will be offset by grants from the endowed fund that will lessen the impact to tax payers.

# Our Slogan in Action

Last August, the GCCF board heard an idea that really caught their attention. It was about a "giving day" held in a much bigger city with a much older, more established foundation.

But, we began to imagine how we could use the idea and adapt it to our small, rural community. Serious questions lingered. Was there enough time to organize such an endeavor for the fall of 2012? Was it a concept the community would respond to?

A small group formed to wade

through the details and present a plan to the Board of Directors at their September meeting. An energized board approved the idea, Grant County Gives was born and the rest is history!

The community response was tremendous!

- 19 non-profit groups and agencies stepped up to sign an agreement to use the money in Grant County.
- ♦ 12 local businesses + GCCF donated a total of

- \$18,000 in matching money.
- ◆ A total of \$76,708 was received and distributed to the participating organizations.

#### We were totally humbled by the generosity of our community!

The board of directors has decided to coordinate the event again next year. We've received excellent suggestions for improvement that we plan to implement for the event next fall.

## It is all about the GRANTS!

It seems like we talk incessantly about building endowments in the foundation. But, it is really about returning Grant County money to Grant County citizens forever.

Many folks are generous about sharing their blessings, and GCCF is pleased to be a local alternative for charitable giving. All too often, the national charities consume a large portion of the donations received in administration and salaries.

Not so with GCCF. As an affiliate of Western Ks. Community Foundation, management fees on our funds are a low 1% plus the investment fee of 0.35%. A small percentage of the earnings is retained in the fund & the rest is paid out in grants to organizations serving Grant County citizens.



In 2012, GCCF paid out a total of \$87,062 in grants. This total includes

Grant County Gives. In addition, WKCF made grants totaling \$7,198 to groups in Grant County.

Since our beginning in 2006, \$188,380 has been granted to groups serving Grant County from WKCF and GCCF working together.

Over 30 different groups and organizations in Grant County have received grant funds from the combined efforts of GCCF and WKCF.

## Tools for Professional Advisors

Last August we joined 2 other community foundations to sponsor a workshop featuring Kathryn W. Miree, JD, a nationally recognized speaker on gifting options. It provided for 2 hours of KS-CLE for attorneys and CE for accountants, financial planners and insurance agents. It was well received.

#### **Good News!**

## Are we on track for Grow II?

The short answer is "Yes", and we are so grateful to the Kansas Health Foundation for the grant opportunity called GROW II and to our community for its generosity in meeting the benchmarks!

Through this initiative, provided certain bench marks are reached throughout the 6 year program, Kansas Health Foundation will provide:

Up to \$300,000 in matching funds for new endowed donations with a 50% match for operating,


general health initiatives and unrestricted grants. And a 25% match for all other endowed gifts except scholarships.

- A grant of \$10,500 each year for operating expenses.
- Assistance grants provide additional resources for education and advisors.

These will strengthen the community foundation's ability to better serve our community now and in the future.

Last April, we received our first \$10,500 grant for operating expenses. Before this grant, we had no budget for essential operations and were astonished at what a difference this small amount made. Part of this money was donated to the matching funds pool for Grant County Gives. We have qualified to receive another operating grant in April of 2013.

In addition, endowed donations were added to the foundation in 2012 to qualify for \$74,500 in matching funds from KHF.

# **Now Accepting Gifts of Grain**

For many cash basis farmers, significant tax savings can be achieved by donating crops directly to the Grant County Community Foundation.

#### **TAX SAVINGS**

<u>Cash</u> charitable contributions are deductible only as an itemized deduction from adjusted gross income which results in reducing federal income tax only. Many farmers do not itemize deductions because the standard deduction has greatly

increased over the years.

By contributing <u>crops</u> to charity the cash-basis farmer avoids including the sale of the cash crop in income <u>and</u> ... Can still deduct the cost of growing the crop, which results in saving self-employment tax, federal income tax, and state income tax.

However, to receive these savings, the transaction must be executed properly.

#### **Timing**

Gifts of grain can be donated from the current or previous year's harvest.

#### **Unsold commodity**

The gift should be from unsold crop inventory with no prior sale commitment. The farmer transfers ownership of the grain to the Grant County Community Foundation.

No Retention of control Farmer cannot offer any guid-

ance in the transfer agreement as to the retention of sale of the gifted grain.

#### Storage costs

After the transfer, Grant County Community Foundation assumes cost of storage, marketing and transportation.



# **Presidents Perspective**


What a great year 2012 turned out to be for the foundation. With new donations and earnings, the assets of the foundation grew to \$457,009 in 2012.

When we have successfully completed our GROW II challenge, Kansas Health Foundation will have paid one half of the \$300,000 grant or \$150,000 into an endowed fund earmarked for general health initiatives. ## Types of Funds Available

#### **AGENCY FUNDS**

These funds are established to benefit the sponsoring organization. The organizations have the availability of creating both a permanent and nonpermanent fund. The intent of these funds is to help them ensure the future of the causes for years to come.

#### **DESIGNATED FUNDS**

The Foundation serves as a partner with donors in a very special way to specify a particular organization or particular cause. The Foundation makes these grants perpetually.

#### **DONOR ADVISED FUNDS**

These funds are typically used to promote "family philanthropy" by having donors and their heirs suggest possible grant recipients. This type of fund provides great flexibility to the donor while avoiding the costs and demands of a private foundation. The donor has the option of creating a permanent or nonpermanent fund.

#### **FIELD OF INTEREST FUNDS**

These funds offer support to charitable causes of particular importance to the donor. Donors become partners with the Foundation by specifying the area that most concerns them. The Foundation then makes grants to the most appropriate programs or organizations within that specific area. Fields include: Arts/Culture, Education, Health & Well being, Environment, Human Services, Recreation, Development and Youth.

#### **FUNDS FOR THE FUTURE/LEGACY SOCIETY**

These funds are deferred gifts that will transfer assets to the Foundation at some future time. The donor may specify the purpose for which these funds are to be used when the fund is established, or the donor may decide to let the Foundation make grants where the funds are most needed in the community.

#### **UNRESTRICTED FUNDS**

This type of fund is for donors who have broad community interests and want to give the GCCF the most flexibility in deciding what organizations their funds should support. Donors who establish unrestricted funds become partners by entrusting their assets with the Foundation. They are assured that the Board of Directors would direct those funds to the organizations addressing the community's most pressing needs.

One of the truly wonderful features of the community foundation is the flexibility it provides to structure gifts to meet the needs and wishes of each donor. The Grant County Community Foundation has a truly amazing format to create funds and tailor gifts to meet a donor's charitable goals. In addition to cash, gifts of other assets can be accepted, such as real estate, mineral rights, stocks, life insurance, etc. Deferred gifts through estate plans, wills or trust documents are also an option.
