Kids at Risk?—Let's tackle it!

In visiting with people in our community who are in a position to know—

- Underage drinking is on the rise.
- There are concerns about meth use in teens as young as middle school.
- In the Kansas
 Communities
 That Care Student Survey in
 2014, questions
 concerning alcohol, include 30-day prevalence
 and binge drinking had percentages that were trending up.
- The Kansas Opioid Prescriptions by county

(grouped by the CDC) listed Grant County, Kansas in the highest quartile for opioids prescribed here.

Last spring the GCCF Board of Directors voted to apply for a Planning Grant from the Kansas Department of Aging and Disability Services to study and develop a comprehensive plan to address underage drinking and drugs in Ulysses and Grant County.

We were approved for the planning grant!



Our role as the Grant Director is to convene a leadership team that will study the issues and develop a plan. We will also be responsible for attending the required training meetings, making monthly reports and handling the grant money.

Over the coming year, a coalition of 16 people representing various sectors of our demographics will meet monthly to identify the depth of the problem in our community and develop solutions that will be effective right here at home.

GCCF—A local option for Memorial gifts

Did you know?

The community foundation is honored to receive memorial gifts and will handle your gifts according to your instructions.

Memorial gifts are acknowledged to both the donor as well as the family, so you have a receipt and the family is informed of your gift. A few ideas are:

- The family can direct the memorial gifts within the foundation.
- Or the family may choose to start a fund in the foundation to honor their loved one with annual grants to an organization they supported during their life.
- As a friend who cares, you can donate to any of the funds already in the foundation.
- You can also donate to the general Memorial Fund in the Community Foundation from which grants are made to support local causes.

The President's Perspective



Elimination of taxes can be a powerful tool which involves not paying taxes at all on specific types of income being generated.

One method

of eliminating taxation includes gifts or donations to charities, which is utilized by many tax payers as a tax deduction when calculating their income tax liability.

Charitable donations may be in the form of giving cash, checks or even property. If a donor makes a gift of property, the donation is

based on the fair market value of the property, not its original cost. On the other hand, if an individual sold the property, and its value had increased since purchasing it, the gain on the sale would be subject to taxation at the capital gains rate. Aternatively, if the property is donated to a charity, the capital gains tax on any increase of the value of the property is eliminated. Charitable gifts of property therefore have two tax benefits: 1) the deduction for the donation and 2) eliminating taxation of the capital gain.

When determining what is best for your financial wellbeing related to tax savings through charitable con-

tributions, seek guidance from a reputable accountant or tax preparer.

*The IRS website states, "Most tax return preparers provide outstanding and professional tax service. However, each year, some taxpayers are hurt financially because they choose the wrong tax return preparer. Be sure to check our tips for choosing a tax preparer."

Gifts of Grain

Are you a grain producer? Did you know you can donate grain directly to the Grant County Community Foundation?

The Foundation has established an account with some of the local elevators to receive your grain. All you need to do is tell the elevator you are making a gift of grain. It is as easy as that. Then, make a simple telephone call to the foundation to let us know how to direct your donation.

For many cash basis farmers, significant tax savings can be achieved by donating crops directly to the Grant County Community Foundation.

By contributing crops to charity the cash-basis farmer avoids including the sale of the cash crop in income and can still deduct the cost of growing the crop, which results in saving self-employment tax, federal income tax, and state income tax.*

- Gifts of grain can be donated from the current or previous year's harvest.
- The gift should be from unsold crop inventory with no prior sale commitment.
- The farmer transfers ownership of the grain to the Grant County Community Foundation.
- Farmers cannot offer any



- guidance in the transfer agreement as to the retention or sale of the gifted grain.
- After the transfer, Grant County Community Foundation assumes cost of storage, market-


